Further, agreement concerning any programmes shall provide details concerning the specific commitments made by each party and shall not become effective until they have been reduced to writing executed by the duly authorized representative of parties.

For agreed upon activities ,both institutions will make available their facilities and staff.

This collaboration will take effect on and will be valid for one year that is.,
